Every attempt will be made to hold this event as scheduled. In the event of an "Act of God" such as fire, flood, etc the event may be cancelled. We will make every attempt to contact exhibitors/entries refunded as appropriate.


SITE CRATING:

Crating will be in vehicles for this event. Come prepared for any weather. It could be cold, snowy, windy, etc. Do not forget water and gear for you and your dogs in case of extreme cold. At no time should a dog(s) be tied out or otherwise left attached to something other than a human; **DO NOT** leave your dog(s) tied to an unattended chair or an open crate.

SITE DETAILS:

- The trial ring will be held inside of a working horse barn.
- There is one ring with a matted concrete floor.
- One wall is a fenced exterior wall looking out at a gravel drive and field.
- White lattice fencing and barn walls will make up the other 3 ring sides
- Blind will hold 3-5 dogs depending on the class. A large horse stall will be divided into sections using lattice. Other accommodations can be made if requested.
- This is a working boarding and training facility, please be respectful.
- Please pick up after yourself and your dog.
- Trial grounds are the parking lot and area by the barn and training center building. This test will be in the BARN, not the climate controlled training center building. The grounds are mostly grass and gravel.
